The Board of Supervisors Meeting was called to order by Chairperson Linda Evans-Boren at 7:02 pm. He also explained that the tires which had been approved last session were no longer available and that a different tire must be purchased, increasing the price by \$750. Mr. Frye directed the Board to his written report on all other items.

Mr. Ivery said that he was still working on the issue of the shed at 6060 Route 88 which was requested to be moved to the back of the house. All other items are in his written report.

Mr. DeiCas directed the Board to his written report. In regard to the MS4 NPDES permit, he explained that he had attempted to get a General Permit but that an Individual Permit is necessary due to the Mingo Creek watershed along Garvin Road being classified as high quality. He also said that all outfalls and cross drains need to be mapped and that the Road Superintendent should get started on the mapping. He will explain the details to him later, but Mr. Banahasky has a map which needs to be updated.
